FISHERIES

Great news! The Fisheries & Aquaculture Sciences program has an overloaded first year cohort and is looking forward to a new academic year. Of the incoming class, 48% are from outside Whatcom County and students have moved to Bellingham from Hawaii, California, Arizona, New York, Alaska, and Oregon to join the program. The program also has 100% retention from the previous spring quarter and second year students are working with instructors on a National Science Foundation (NSF) pilot project with the Ocean Observatories Initiative for oceanographic research. Of the graduating cohort from last year (June 2021), 83% are already working in fisheries and/or aquaculture related fields. Also, the Virginia Institute of Marine Science reached out to our program to recruit BTC graduates for shellfish jobs on the East Coast. We are currently setting up this pipeline to support the East Coast aquaculture workforce needs.

GRANTS

BTC partnered with the other technical colleges in Washington state on an Institutional Resilience and Expanded Postsecondary Opportunity (IREPO) grant application. This project is led by Lake Washington Institute of Technology and the grant was awarded in August. BTC will receive \$442,462 over the next two years, and will use this funding to provide additional eLearning support for students and faculty, as well as providing supplies and equipment to help BTC professional technical programs improve the quality of their hybrid and online offerings.

DATA & RESEARCH

October 25 marks the date that Bellingham Technical College will officially go live in PeopleSoft, our new student management system that is being implemented across all community and technical colleges in the state. While we know the new system will be a tremendous upgrade, it will also significantly change the way we operate here at the college and take a lot of legwork to get up and running. That is especially true for us here in Data & Research! If you are an individual who relies on us to provide data to help you with your work – in our dashboards or otherwise – here is what you'll need to know after we "flip the switch."

First, you'll still be able to access our BTC data dashboards, but they will be frozen, and no new data will be added for an extended period while we use the new system to rebuild the databases where they draw their data. Second, since we will be rebuilding our databases from scratch, we will be extremely limited in our ability to fulfill data requests. If you know you will need data, please plan accordingly and **submit your request** well in advance of when you'll need it. Third, PeopleSoft includes some built-in options for pulling data and reports, but since they are independently built and verified by users at other colleges and the State Board, we cannot guarantee the accuracy of the data they return. If you think you will need to pull data in this manner, please reach out to the Data & Research team and we will work together with subject matter experts on campus to verify their accuracy. Finally, it is to be expected that some of our data will look slightly different than it did before while we iron out the kinks in this completely new system. You can help us a great deal by notifying us anytime you find an oddity or something that looks a little strange. Together, we will be able to get back on our feet data-wise in no time!
